c. Discussion:

National Leak Detection

Mr. Valdez met with a representative from National Leak Detection out of Centennial last week. He was told the company could do a leak detection, but they felt Colorado City has a meter problem. Mr. Valdez is going to talk to another company to get a second opinion. He would like to start a meter replacement program to make sure all meters are reading accurately. He said Mr. Daryle Mahaney's numbers for water as stated in the Greenhorn Valley View newspaper the previous week were accurate, to a point. The numbers Mr. Mahaney requested did not include

storage facilities, water in the lines, leaks, water for Rye Fire Department and other factors of that nature. Mr. Valdez said the water loss for CCMD is close to 20% which is lower than most cities of this size.

Mr. Valdez let the board know the auditors are here to start the annual audit.

Mr. Valdez said the meters at Kasel Industries are scheduled to be worked on next week and the water will be turned off in that area for a few hours.
