## 1. Property Offers:

Presented By District Manager Eccher. These offers have been denied before in a prior meeting they are present at the meeting for further reconsideration. They are present to share their ideas of how the sale can benefit an apartment complex to the community. They are asking for our goals and wanting to help them establish why they are best to purchase this property at this time. Discussion took place. They are trying to bring more to the community with the board approval. Another offer was brought to the attention of the Board. District Manager Eccher, did share within this aspect that a new sewer line and infrastructure changes may need to be made at this time and with due cost to the Metro. Both Parties are willing to take part in the dollar amount. At this time the board would like to table until further research can be completed and further offers can be studied before moving forward.

#### 2. Audit:
